5. Every receipt issued to a donor shall bear the **File Number** i.e. DIT(E) No.2(502)/05-06/80G and date of this order i.e. **23.08.2017.**
6. Under the provisions u/s 80G(5)(i)(a) the institution/fund registered u/s.12A, u/s.12AA(i)(b) or approved u/s.10(23C), 10(23C)(vi)(via), etc., shall have to maintain separate books of accounts in respect of any business activity carried on and shall intimate this office within one month about commencement of such activity.
